

Lent: A Journey as Stewards

*Each one of you has received a special grace,
so like good stewards responsible
for all these varied graces of God,
put it at the service of others
(1 Pt 4:10)*

Introduction:

In this time of Lent, we are reminded again to “stand fast in the grace of God” (Pt 5:12) as God has entrusted this gift (*chárisma*) to us - as servants (*diakonia*), dispensers (*oikonomoi*) of grace.

Each of us is called, therefore, to become a treasurer, a steward of ‘varied graces’ that are expressed by our charism and are to be made available to all for the benefit of all.

Every member of the community, therefore, rich in this gift, takes an active, co-responsible role in community life.

ASH WEDNESDAY

Jesus said to his disciples:

"Take care not to perform righteous deeds
in order that people may see them;
otherwise, you will have no recompense
from your heavenly Father.

Mt 6:1

Christ willed to be born, to live and die poor.
Having given the example, he calls those who wish
to be His followers, to be poor in spirit,
to be detached from material possessions,
to have filial confidence in God and
to tend towards that joyful liberty of spirit
which will enable them
to give themselves entirely for His service
Const. 18

READ

Holy poverty is what makes persons interiorly free, and allows them to grow in faith and charity, a charity that has eyes able to see the needs of others, and to have a merciful heart to help them. Holy poverty is animated by the love that places others before itself, and puts its trust in God, who provides for His creatures every day, like the lilies of the fields and the birds of the sky (cf. Mt. 6:25-34).

Holy poverty is recommended by Jesus to the young man who went away sad because he had many goods (Mk. 10:22) and wanted to keep them for himself. The master had suggested that he sell everything so as to lead him to interior freedom and to mercy that is authentic and generous. Poverty leads to charity and thus enters into the contemplation of the mystery of God.

REFLECT

Am I living *Holy Poverty*?
Am I a living memory of the Poor Christ?

PRAY

Good and loving God, Source of every grace and blessing, we bring You thanks this day for the many gifts You have given us. As we begin Lent, we pray for the strength to commit ourselves to become good stewards. Lord, bless us as we continue to live in poverty like Christ.

that you have received until now.
Then list all the gifts
that you share with others,
in your ministry and in your community.

FIRST SUNDAY OF LENT

*He gave us this land

READ

“Fidelity to the founding charism and to the subsequent spiritual heritage of each Institute”⁷ is, together with the demands of the Gospel, the first evaluative criteria for decisions and actions that take place at every level, because “the nature of the charism directs their energies, sustains their fidelity and directs the apostolic work of all towards the one mission.”

It is necessary, therefore, to undertake a review of the mission as an expression of the charism to verify if the charismatic identity of established works continues to emerge in the current operational activities.

READ

Money in itself is a good instrument, as are many other things at the disposal of the human person, and is a means to order one's freedom and to expand one's possibilities. Nevertheless, the means can easily turn against the person. Likewise, the financial dimension of the business world, focusing business on the access of money through the gateway of the world of stock exchange, is as such something positive. Such a phenomenon, however, today risks accentuating bad financial practices concentrated primarily on speculative transactions of virtual wealth, as well as negotiations of high frequency trading, where the parties accumulate for themselves an excessive quantity of capital and remove the capital from circulation within the real economy.

READ

Responsibility, transparency, and the maintenance of trust are interconnected principles: no responsibility is given without transparency, transparency generates trust ...trust verifies both. Responsibility is the principle of awareness that relates the evangelizing mission to the Church's assets.

REFLECT

Am I aware of my responsibility in the Congregation?

PRAY

READ

Management of Assets and Stable Patrimony

It is understood that patrimony consists of all fixed and movable assets, all rights, assets and liabilities of the juridic person. This patrimony, which is essential to the life of the institute, cannot be put at risk. In light of this it is critical to rethink and deeply study, in the respective ecclesial and legislative contexts, the canonical norms pertaining to the so-called "stable patrimony".

The Code of Canon Law does not explicitly define this. It presumes the classical understanding, emanating from the canonical doctrine of "assets legitimately designated" as being a permanent endowment (whether capital goods or income) of the juridic person for the purpose of facilitating the realization of the goals of the institute and ensuring economic self-sufficiency.

READ

REFLECT
